

## INFORMATION NOTICE

### Travel Restrictions on Lorries 12T+

Vehicles with a weight of above 12 tonnes (inclusive of the weight of trailers and semi-trailers), will not be allowed to use particular sections of roads in the Republic of Bulgaria, on certain days and at certain times. This ban also applies to agricultural machinery.

The restrictions are in force on the respective roads and dates as shown below:

I-1	From Blagoevgrad to Kulata BCP, in both directions

I-5	From Ruse to Veliko Tarnovo, in both directions
I-8	From Kalotina BCP to Sofia, in both directions
II-8	Sofia ringroad
I-9	From Varna to Burgas, in both directions
II-99	From Burgas to Tsarevo, in both directions

**N.B.** These travel restrictions do not apply to vehicles transporting dangerous materials (ADR), livestock, perishable foodstuffs or refrigerated goods.

## RECOMMENDATION:

Drivers of vehicles subject to the road restrictions are advised to check their proposed route map and dates against the restrictions table shown. It is advised that drivers pre-plan stops if travelling at a time when restrictions are in force.

## CONSEQUENCES OF NON-COMPLIANCE: COMPULSORY ADMINISTRATIVE MEASURES

- *Suspension of driving licence and a driving ban for one (1) month – imposed on the DRIVER, who has continued to drive in violation of, and contrary to, the restrictions in place at the time (Art. 171.1, section 'g' of the Road Traffic Law);*

- *a ban on using the vehicle on the roads for a period of three (3) months – imposed on the OWNER, regardless of whether s/he was driving the vehicle or whether s/he allowed another person to drive the vehicle in violation of, and contrary to, the restrictions in place at the time (Art. 171.1, section 'n' of the Road Traffic Law).*

## SANCTIONS

*Sanctions will be imposed on any driver who has continued to drive in violation of, and contrary to the restrictions in place at the time as follows:*

- *A driving ban for a period of one(1) month, AND*
- *A Fine of 300 BGN (Art. 183, Para 7 of the Road Traffic Law)*
