In addition, we have independent permanent technical staff with more than 20 years experience stationed at the factory to ensure that the product meets all technical requirements and has the best visual quality.

Today, we continue to improve on our design and technical quality of our products, and have increased our clientele to France, UK, Spain, and Italy within the EU, and our client list includes the second largest construction company in the UK, the second largest manhole supplier in Spain, third largest manhole cover supplier in the UK and the third largest supplier of manhole covers in France.

In 2017, Lynter have entered a joint venture in Penang, Malaysia for our newest production base and have begun manufacturing our EU products there in 2018. Our new production base has the latest production equipment, such as fully automatic sand moulding machine line for fast and accurate production and CNC (Computer numerical control) for automated and precise product tooling and machining. We expect our new production base in Malaysia will be able to allow us to make our products better and cheaper, and allow us to continue to expand our business.

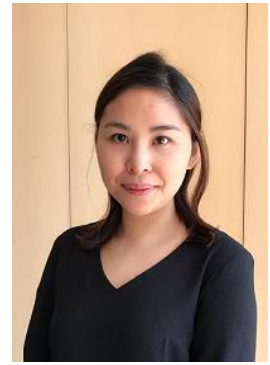
