

## Decision

Number: 38/2017

### Amending services duties provided by General Directorate of Customs

Referring to Oman Royal Police law issued by Royal Decree number 35/90,  
The Royal Decree number 67/2003 of applying GCC Common Customs Law,  
And to Ministry of Finance approval,  
And according to the public interest,

We hereby decide the following:

#### First Article

Replacing the following duties with the services duties provided by General Directorate of Customs:
