PUBLICATION GUIDELINES

1. Format

Please send your paper in electronic form to our editor (redaction.wpb@wko.at). Save your document in a format compatible with MS Word for Windows (preferably MS Word 97-2007). If you work with Apple Macintosh, be sure to convert your document into a MS Word for Windows compatible version. If your paper contains **graphs or figures**, **save these separately** from the text document and send them both as an electronic file. The **length of an article should not exceed 25.000 - 30.000** characters unless otherwise agreed with the editor.

2. Components of the Article

An article contains the following elements.

- Title
- Subtitle
- Information about the author
- Abstract
- Article
- List of references
- JEL-Code

2.1. Abstracts and JEL-Code

Please include a short description (max. 1000 characters) of the content (summary) of your paper. The title and the summary are included in the catalogue of the Journal of Economic Literature. Be sure to append the appropriate JEL-code to your article. A list of the codes can be found at

3. Titels

When using titles and subtitles use the following format:

1. Titel 1
- 1.1. Titel 2
- 1.1.1. Titel 3

4. Tables and Figures

Tables and figures should be numbered sequentially:

Table 1, Table 2, etc.
Figure 1, Figure 2, etc.

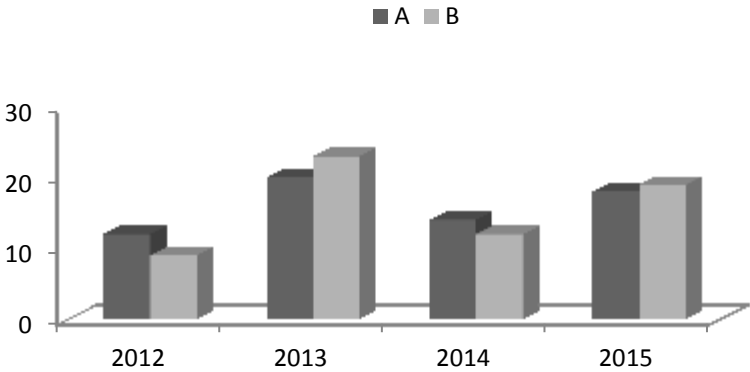

5. Quotes or citations

In the text:

(author-surname, year);	Example 1a
(author/author, year, page)	Example 1b
(author, year; author, year)	Example 1c
(newspaper or journal, year)	Example 1d

No „see below“ or „page“

In the references or bibliography:

In the references: full stop after every quote!

Books:

author's surname, first initial (year), title, place	Example 2a
first author's surname, first initial/second author's surname, first initial/ third author's surname, first initial (year), title, place.	Example 2b
institutions are treated as single authors	Example 2c
if more than one publication of the same year by the same author are quoted, please distinguish by using a, b, c after the year	Example 2d

Article in a book:

author's surname, first initial (year), title of article, in: editor(s)'s surname(s), page no.	
in alphabetical order: editor's surname, first initial, ed., (year), title, place.	Example 2e

Article in a periodical:

author's surname, first initial (year), title of article, periodical nummer, page	Example 2f
---	------------

Article in a newspaper:

author's surname, first initial (year), title of article, newspaper or journal title (exact date), page.	Example 2g
when no author is named: newspaper or journal title (exact date), title of article, page.	Example 2h

Quotation from the internet:

Following the MLA-style (http://www.tsufl.edu/library/5/mla.htm), in addition quote also URL and date of access	Example 2i
