In order to provide a comprehensive and analytical overview of the situation in the glass industry, this report provides statistics for the whole glass industry together and statistics for each of the glass sectors. The situation varies a lot between the different sectors.

I. Introduction – Commentaries

State of the Industry

Note: *In 2020, we have to take into account the fact that the UK left the EU. Eurostat external trade data therefore cover now EU-27.*

The other production statistics in this report cover EU27 + UK to maintain the same geographic scope as previous years (unless indicated otherwise).

2021 showed a slow recovery from COVID-19 crisis as the normal operations of most glass sectors were disrupted since 2020. The market suffered from the pandemic at different levels according to each glass subsector with some companies being more exposed to the effects of shut-downs than others resulting in them coming under severe financial pressure.

Overall **glass production** reached a volume of **39.12 million tonnes**, an **increase of 6.1%** compared with 2020, which indicates that the market has partly recovered from the drop of 8.1% in 2020 compared with 2019.

The European production level still maintains the EU as one of the largest glass producers in the world with China and North America. Germany remains the EU's biggest producer with about one fifth of the volume, closely followed by Italy, France, Spain, UK and Poland.

Regarding **foreign trade from third countries**, imports from Asian countries, and in particular China, remain big competitors.

Compared with 2020, 2021 extra EU-27 **exports increased by 16.4% in volume** at 4.45 million tonnes and **by 11.7% in value** with 8.13 bn Euros. The EU-27's four major clients in volume are the rest of Europe (62%), including UK (23%), Switzerland (12%), Turkey (7%), Serbia (3.9%) and Russia (3%), followed by the USA (9.4%), North Africa (7.5%) and Far East Asia (5.7%) including China (2.3%).

As for extra-EU27, **imports** in 2021 also **increased** compared with 2020, **by 20.7% in volume** (5.5 million tonnes) and **by nearly 32% in value** (7.96 bn euros). Far-East Asia accounted for 31.2% (including 24.5% from China alone), the rest of Europe for 57% (*including UK (14.75%), Turkey (10.8%), Russia (9.5%), Switzerland (6.9%) & Ukraine (7.3%)*), North Africa for 4.8%, United Arab Emirates (1.5%) and the USA for 1.7%.

Employment 2021

The number of employees stabilized since 2013. Currently, the EU-27 glass industry employs about 181,000 people (incl. processors), showing a small decrease by 2.7% compared to 2019 pre-covid period with 186,000 people.

Outlook

Behind these 2021 figures aggregated at the level of the whole glass industry, it is important to realize that the **situations are contrasted in the different sectors**. Evolutions in production and employment, as well as in the origin of imports into the EU, are very different between glass sectors. The global trend indicates however steadily increasing imports in all glass sectors with rather reasonable exports. Investment outside the European borders has materialised and imports are gradually and insidiously increasing, taking bigger EU market shares in all glass sectors.

With tough market conditions, a still difficult global sanitary situation and the new conflict between Russia and Ukraine, competition remains intense with non-European glass manufacturers and consumer confidence to invest in glass is difficult to restore when energy costs are rocketing so high.

For 2022, next to the high influence of worldwide context and the Ukrainian conflict in Europe, the recovery of the economy will remain very dependent from the implementation of the national recovery plans and of the EU state aid programmes to support the industry and promote a new industrial climate-friendly era.

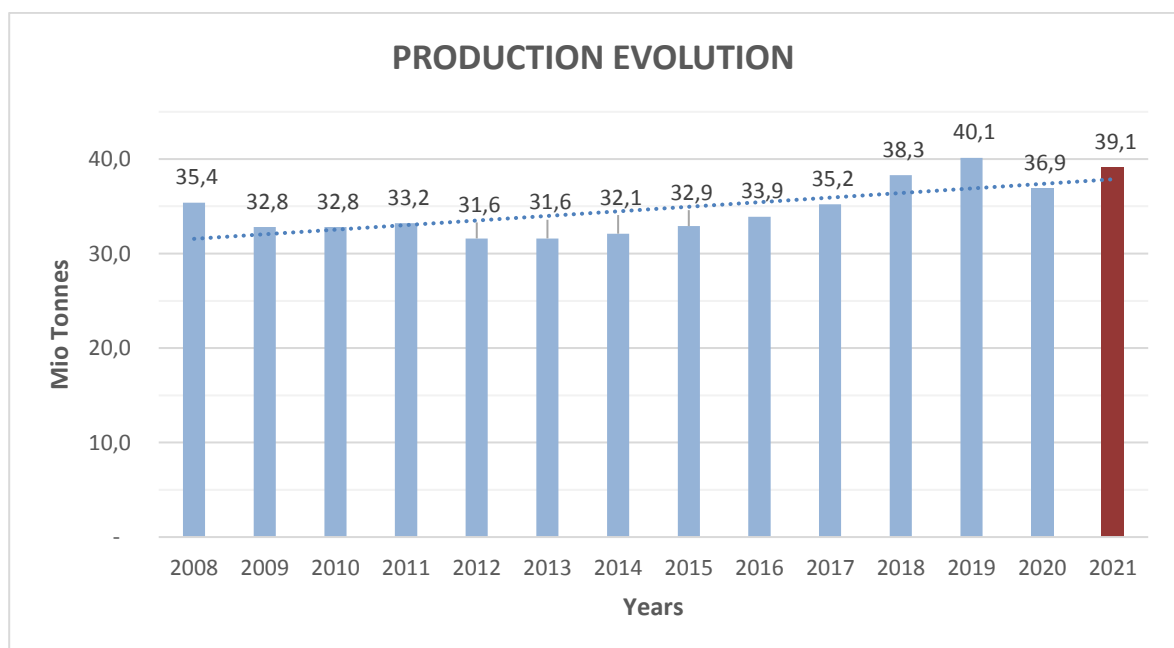

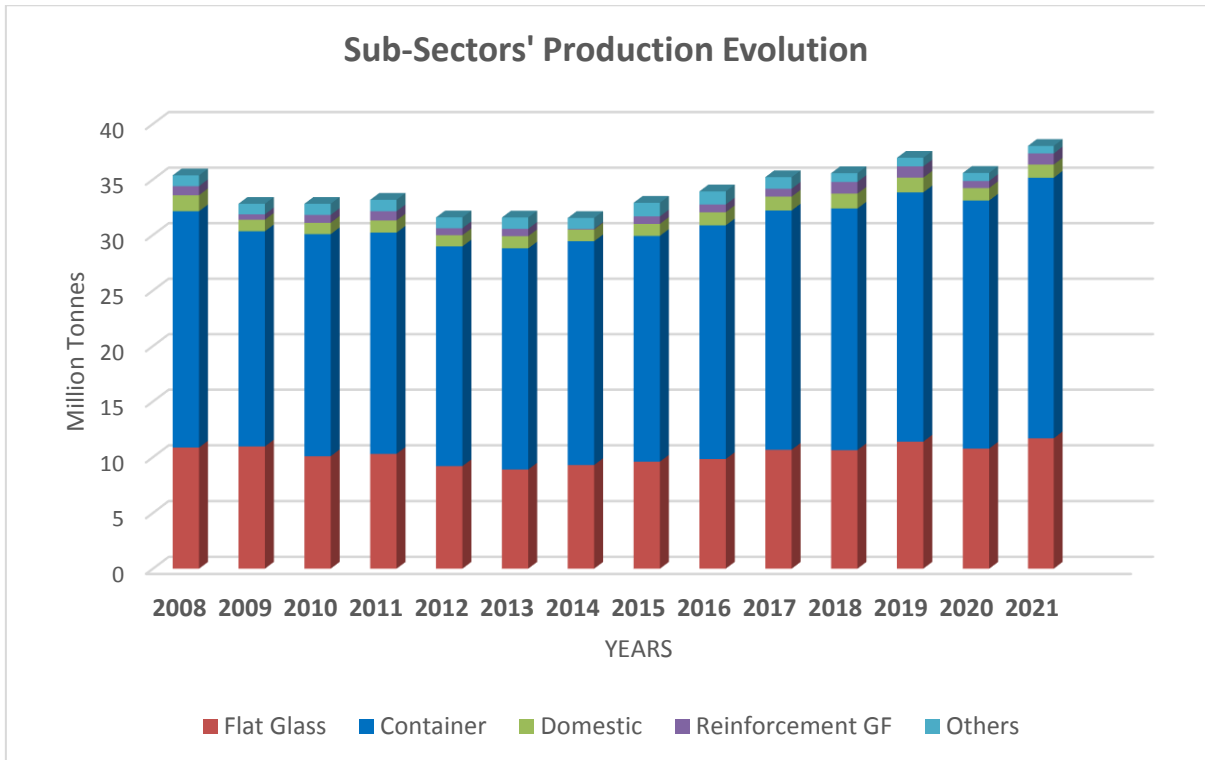
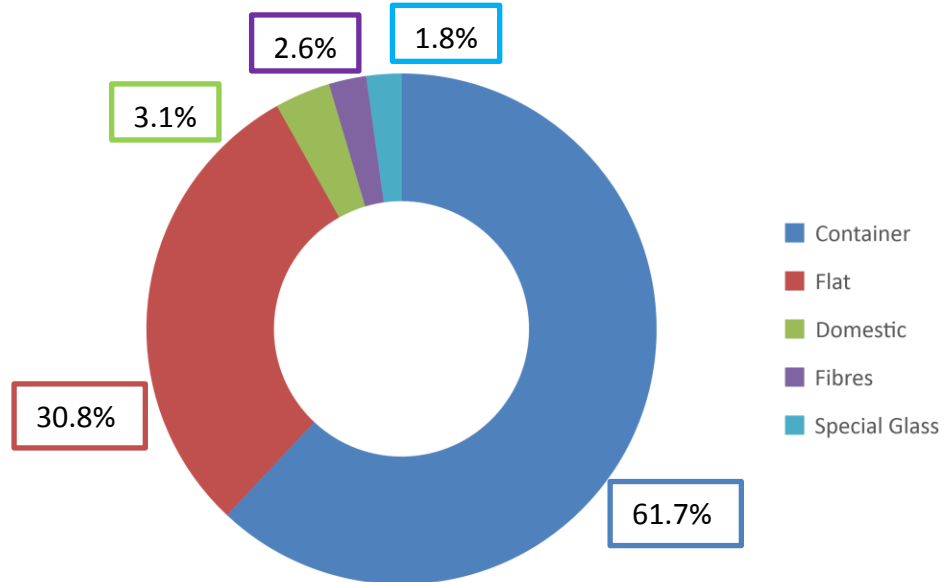
Reported production by sectors refers to saleable glass, except for the flat glass sector where production expresses the tonnage of melted glass.

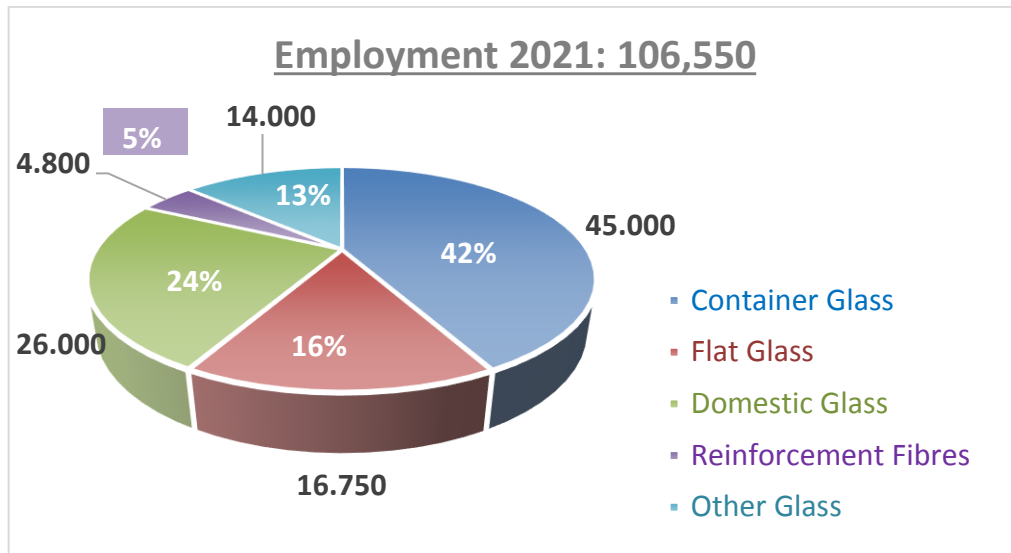
The production rate of GAE membership increased in 2021 compared with 2020 by 6%. Compared to 2008 index (100), sectoral production reached index 107.7 for flat glass, 110.3 for container glass, 82.3 for tableware and crystal, 108.3 for continuous filament glass fibres and 70.6 for other glasses.

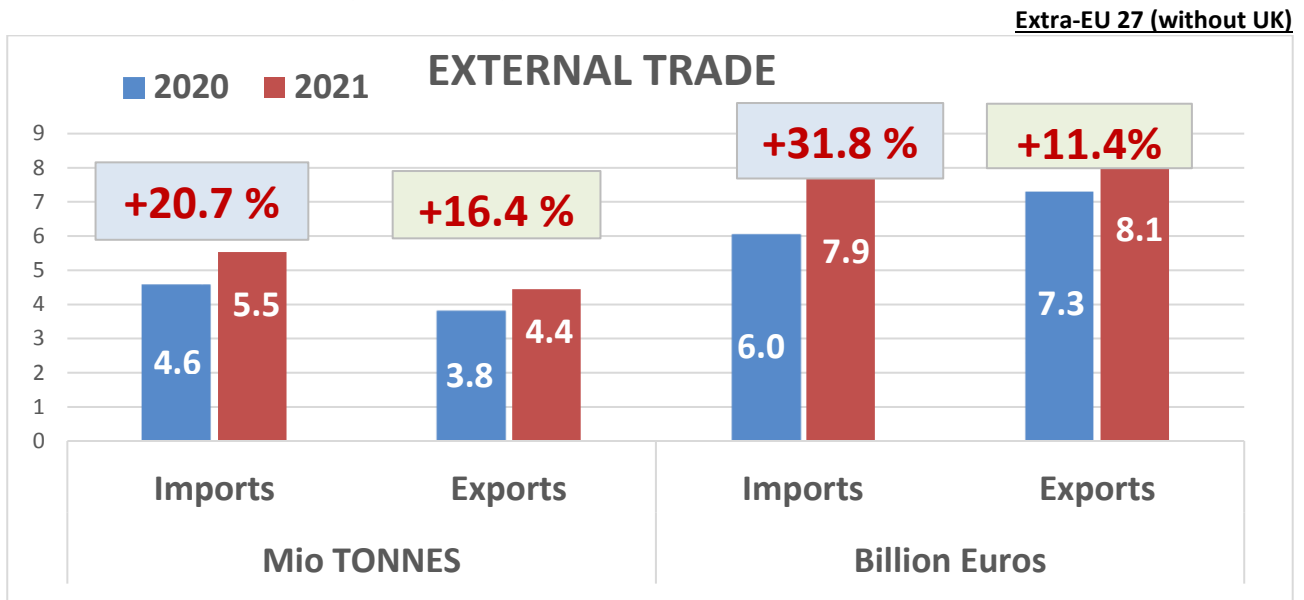
