E-waste

The Waste Electrical and Electronic Equipment (WEEE) amending Directive has been published in the EU's Official Journal. It will enter into force on 8 April 2024 and Member States will have until 9 October 2025 to transpose the Directive into national law.

Earlier in March, the Council of the European Union had adopted amendments to WEEE legislation, which includes a range of products such as computers, fridges and photovoltaic panels. The amendments aim to bring the WEEE directive into line with a 2022 EU Court of Justice judgment on the partial invalidity of the directive owing to unjustified retroactive application of extended producer responsibility to waste from photovoltaic panels placed on the market between 13 August 2005 and 13 August 2012.

News from the Member-States

Starting from 1 January 2025, Belgium will be the first in the EU to ban the sale of disposable e-cigarettes (vapes), federal Health Minister Frank Vandenbroucke announced, with a royal decree soon to follow. Disposable e-cigarettes are classified as "Electric and Electronic Equipment" (EEE) under EU, UK, and EEA producer responsibility regulations. However, many producers and distributors don't register them, leading to a lack of contribution to the WEEE treatment system. This is primarily due to awareness issues, free-riding, and weak enforcement.

EuRIC has urged the European Commission to impose restrictions under REACH and impose an EU-wide complete ban on single-use e-cigarettes by the end of 2024, due to their negative impact on health, the environment, communities, and the circular economy.

Critical Raw Materials

the Commission to adopt delegated acts supplementing this Regulation and set minimum recycled content targets for certain materials in permanent magnets. Recycling and processing projects will receive their permits faster than extraction projects, within 15 and 27 months, accordingly.

The European Commission has signed a new strategic partnership agreement with Norway on sustainable land-based raw materials and battery value chains. The Memorandum of Understanding (MoU) was signed by Maroš Šefčovič, Executive Vice-President for the European Green Deal, Interinstitutional Relations and Foresight of the European Commission, and Jan Christian Vestre, Minister of Trade and Industry of the Kingdom of Norway.



Textiles

During the Environmental Council of 25 March, the delegations of France, Denmark and Sweden urged the Commission to subject textile waste to the control mechanisms of the Basel Convention in an effort to address the issue of increasing textile waste.

The three countries requested the EU Executive to put forward a draft Council Decision for a common EU proposal before the 17th Meeting of the Conference of the Parties, scheduled for next spring. The delegations asked for provisions similar to the regulation of e-waste under the Basel Convention. This would mean:

- requiring prior informed consent to be obtained for the import and export of textile waste
- banning the export of hazardous textile waste (e.g. stained with chemicals or paint) altogether

On 13 March, the European Parliament adopted its position on the revision of the Waste Framework Directive (WFD). EuRIC's Textiles Branch welcomed the vote as a step forward, regretting, however, the fact that no concrete targets for textile collection, reuse and recycling were set. A prompt entry into force is now essential.

Waste Shipments

On 25 March, the Council adopted the revised [waste shipment rules](#), which marks a significant step towards modernising intra-EU waste shipments rules and tackling illegal shipments. The measures aim to ensure that waste is only sent to destinations where it is properly treated in an environmentally sound manner, and updating shipment procedures to reflect the objectives of the circular economy and climate neutrality. EuRIC welcomed the updated rules facilitating intra-EU waste shipments with the explicit goal of achieving a circular economy, and clarifying that unintentional administrative errors do not render a whole shipment illegal. Yet, concerns remain.

Packaging

On 15 March, COREPER signed the deal on the Packaging and Packaging Waste Regulation (PPWR), marking a significant milestone for the European recycling industry and circular value chains. The deal reached is likely the best outcome, given the trade issues that caused delays and the fact that it was only reached after any condition of origin for plastics accounting for recycled content was removed. EuRIC applauds the milestone deal, but also highlights that challenges remain. Earlier in March, the Parliament and

The trilogue deal included a mirroring clause mandating that recycled plastic originating from third countries meet stringent EU environmental standards to be allowed to account for mandatory recycled content in plastics packaging. EuRIC and FEAD teamed up to highlight the need for robust recycling infrastructures and a strong market for European recycled plastics. With the upcoming ban of plastic waste exports, meeting EU recycling targets will depend on these conditions.

Other EU files

Green Claims Directive:

On 14 March, the European Parliament [adopted its position](#) on the Green Claims directive, a significant step in fighting greenwashing and ensuring a level playing field for responsible companies in the EU. The directive would oblige companies to provide robust and verifiable scientific evidence for their environmental marketing claims before labelling products as “biodegradable”, “less polluting”, “water saving” or having “bio based content”. It also extends to environmental claims on products sold via online platforms. While this marks progress in combatting greenwashing, attention is still needed on labelling, verification, and addressing hazardous substances.
